harp-weaver serves as the outsourced staff for [The Presser Foundation](#), founded by Theodore Presser, and based in Philadelphia, Pennsylvania. The Foundation provides philanthropic support of music and serves a broad and diverse community of musicians, educators, and music lovers.



We have gained significant knowledge of the field of music, particularly the challenges music organizations have faced during COVID. It's why harp-weaver has advocated for adapting The Foundation's grantmaking practices to optimize support. For example, as many smaller music organizations do not have their own physical spaces, they have been ineligible for funding from the Foundation's Capital Support grantmaking area. As a result of COVID and its damaging impact on in-person attendance of performances, harp-weaver advised the Foundation's board to expand guidelines to include support for equipment (non-instrument) purchases, software, and hardware. Smaller organizations received funding to record and livestream their productions to audiences around the world, a vital way to maintain current audiences, build new ones.
